

Chemical Compatibility Information

Inline diagphram type check valves, all types of filters, self-sealing check valves, ball type check valves, and spring loaded check valves are all products that can, and typically do, contain multiple types of different materials. - **C** = **Not Ideal** -- The chemical has a pronounced effect on the product and will degrade it. Material softening, swelling, loss of strength, corrosion, and discoloration may occur. Use only for limited timespans and replace often.
- **D** = **Severe Effect** -- The chemical has a severe adverse affect on the product and will likely destroy it. Not reccomended for use.
- N/A = No Data Available -- One or more of the materials in the product has an unknown compatibility with the chemical.
