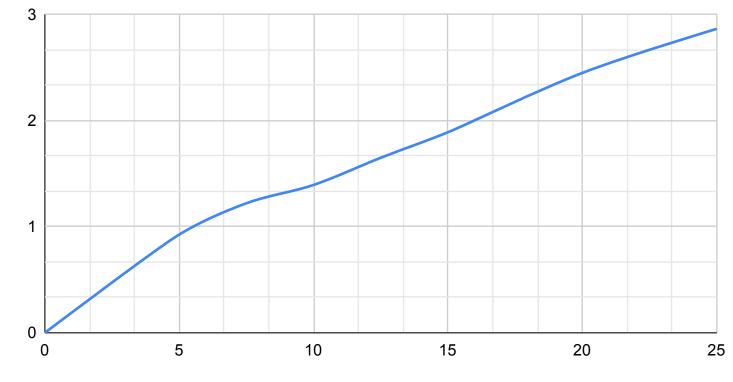

Inline diagphram type check valves, all types of filters, self-sealing check valves, ball type check valves, and spring loaded check valves are all products that can, and typically do, contain multiple types of different materials. The chemical compatibility of the whole product is limited to those chemicals which are compatible with all of the materials present in the product. - **C** = **Not Ideal** -- The chemical has a pronounced effect on the product and will degrade it. Material softening, swelling, loss of strength, corrosion, and discoloration may occur. Use only for limited timespans and replace often.
- **D** = **Severe Effect** -- The chemical has a severe adverse affect on the product and will likely destroy it. Not reccomended for use.
- N/A = No Data Available -- One or more of the materials in the product has an unknown compatibility with the chemical.
